COURSE DESCRIPTION:

In this course, students will be instructed on over a thousand years of history, tracing the beginning of Islam, the rise of radical fundamentalism, and the creation of Muslim terrorist groups. Concepts covered in the course will include: a comprehensive overview of the role of local law enforcement investigators in the global war on terror; local law enforcement response; integration of criminal information and intelligence, an examination of criminal acts committed in support of terrorism, terrorism indicators and warning signs, and ways to access available investigative resources to better assess an emerging situation. In addition, the November 2008 terrorist attack on Mumbai, India will be reviewed. This case study examines the events leading up to, during, and following the attack. The examination will focus on terrorist tactics, response failures, and lessons learned in the aftermath of what has been described as "India's 9/11."

Daewon and Britton were Counter Terrorism Investigation Instructors for the Los Angeles FBI JTTF Task Force Officer Training Program and have provided terrorism training to over 1400 police officers in the state of California, including the Los Angeles Police Department SWAT Team. They currently provide training on behalf of the California Narcotics Officer Association, the Los Angeles District Attorney Criminal Justice Institute, the Joint Regional Intelligence Center and the LADA, Major Crimes, Anti-Terrorism Unit.
